The Commission notified the above post vide Notification No. 07-PSC (DR-P) of 2024 dated: 09.12.2024.


The written test was conducted on 29.09.2025 and the result thereof was declared vide Notification No. PSC/Exam/S/2025/51 dated 12.11.2025. The viva voce of the shortlisted candidates was conducted on 29.12.2025, with the assistance of experts.

On the basis of overall performance, Sameer Ahmad Wani S/o Abdul Hamid Wani R/o 383 Daribal Ganderbal, having secured 82.56 points, is hereby recommended for appointment for the post of Lecturer, Statistics in School Education Department.
